

June 12, 2018
Regular Meeting

The Eaton Town Council met in a regular meeting. Present are Blankenship, Welsh, DeWees, Hicks and Reese.

Council President Blankenship called the meeting to order.

DeWees made a motion to approve the minutes of the May 15, 2018 meeting. Welsh seconded the motion. Motion carried.

Welsh made a motion and DeWees seconded the motion to approve the 5 year road schedule. Motion carried. Hicks made a motion to get bids on the paving for 2018 and include the risers. Welsh seconded the motion. Motion carried.

Wayne from Commonwealth Engineering requested permission to apply for a PER for a \$30,000.00 USDA Grant to evaluate the water system. No match. Reese moved and Welsh seconded the motion to have Wayne apply for the grant. Welsh, Reese, Blankenship and DeWees voted yes. Hicks abstained. Motion carried.

Chief Snodgrass submitted a proposed ordinance that regulates the display of tobacco and /or drug paraphernalia. Hicks made a motion to approve and send to Town Attorney. DeWees seconded the motion. Motion carried. Reese made a motion to start the interview process to replace the part time officer. Welsh seconded the motion. Reese, Welsh and Blankenship voted yes. DeWees and Hicks voted no. Motion carried.

Reese made a motion and DeWees seconded the motion to approve Christopher Qualls application for the fire department. Motion carried.

Delaware County Health Dept. ask Chief Newby if they could use the fire station for a diaper station. Discussion followed. DeWees made a motion to approve. Welsh seconded the motion. Motion carried. Newby discussed selling the 1998 Pierce and 2002 International by a broker and purchasing a 2018 Rosenbauer pumper for \$255,000.00. Reese made a motion and Welsh seconded the motion to approve the purchase of a new Fire truck. Reese, Welsh and Blankenship voted yes. DeWees and Hicks voted no. Motion carried. Reese made a motion to approve completing the credit application from Republic Bank. Welsh seconded the motion. Reese, Welsh and Blankenship voted yes. DeWees and Hicks voted no. Motion carried.

Hicks made a motion to approve Resolutions 2018-6-3 and 2018-6-4 (USDA loan resolution for sewage project). DeWees seconded the motion. Motion carried.

DeWees made a motion to start process on the 2 properties that adjoining property owners will pay \$500.00 for each. Welsh seconded the motion. Welsh, Reese Blankenship and DeWees voted yes. Hicks abstained. Motion carried.

DeWees made a motion and Reese seconded the motion that if someone is wanting to keep goats in the Town limits they will have to apply for a variance. Each home owner would have to apply individually. Motion carried.

Welsh made a motion to approve a building permit for Randy Blair for a garage if the Planning Commission recommends its approval. DeWees seconded the motion. Motion carried.

Hicks made a motion to approve a week's vacation for Travis Hunt when his baby is born. (Before August 1). Reese seconded the motion. Motion carried.

DeWees made a motion and Welsh seconded the motion to send a letter to FSSA stating that the Town does not require daycare centers to have a permit. Welsh seconded the motion. Motion carried.

Blankenship opened a bid for the removal of 5 trees. The bid from Newsome's \$1800.00. DeWees made a motion to approve. Reese seconded the motion. Motion carried.

Hicks made a motion and Welsh seconded the motion that Brittany Webster will have to pay her utility bill in full before she can get water service at 220 N Long Street. Motion carried.

DeWees made a motion to approve a contract with Commonwealth Engineering to update the Town's sewer use ordinance for up to \$5000.00. Welsh seconded the motion. Motion carried.

DeWees made a motion and Welsh seconded the motion to have Cody Burns pick up all the old chairs in the community room and scrap them. Motion carried.

Reese made a motion and DeWees seconded the motion to approve and sign the easement map and right of way certificate. Motion carried.

DeWees made a motion and Welsh seconded the motion to approve the claim docket. Motion carried.

DeWees made a motion to have 2 drains at Long and Indiana Avenue vacuumed out at \$210.00 per hour. Welsh seconded the motion. Motion carried. Snodgrass to do an ordinance proposal for No Smoking in Town Parks.

There being no further business to be brought before the Council at this time DeWees made a motion to adjourn. Welsh seconded the motion. Motion carried.
