ORDINANCE NO. 2023-03-3

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF EATON, INDIANA AMENDING ORDINANCE No. 2020-1-1 REGARDING THE RATES AND CHARGES ASSESSED TO USERS OF THE TOWN WATERWORKS UTILITY

WHEREAS, the Town of Eaton, Indiana (the "Town") has constructed, and operates, a municipal waterworks utility for the purpose of providing drinking water to users of the waterworks utility in a sanitary manner; and

WHEREAS, the Town has opted out of the jurisdiction of the Indiana Utility Regulatory Commission, which had previously controlled the rates and charges assessed to users of the Town's waterworks utility; and

WHEREAS, the Town Council for the Town of Eaton, Indiana (the "Town Council") previously adopted Ordinance No. 2020-1-1, which established the rates and charges assessed to users of the Town's waterworks utility; and

WHEREAS, the Town Council has determined that it is now necessary to amend Ordinance No. 2020-1-1 to properly classify users of the waterworks utility according to consumption to ensure that rates and charges assessed to users for services rendered are nondiscriminatory, reasonable, and just while also producing sufficient revenue to pay expenses incident to the operation of the Town's waterworks utility.

NOW THEREFORE, BE IT RESOLVED AND ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF EATON, INDIANA:

Section 1. Ordinance No. 2020-1-1shall be amended by replacing subsection (a) of Section 1 with the following:

"(a) Monthly Metered Flow Rate (per 1,000 gallons):

Section 2. Ordinance No. 2020-1-1 shall be amended by replacing subsection (b) of Section 1 with the following:

"(b) Minimum Charge (per month):

All metered general water service customers shall pay a monthly Customer Charge based on the size of meter installed (or multiple meters installed—in which case, charges are based on the total of all installed meters). Monthly Customer Charges are listed below and do not include any allowance for water usage.

- Section 4. All existing ordinances shall not be affected by the adoption of this Ordinance except where such existing ordinances or any parts thereof are in conflict herewith, in which case, such conflicting ordinance or parts thereof are hereby repealed.
- Section 5. The invalidity of any section, clause, sentence, or provision of this Ordinance shall not affect the validity of any other part of this Ordinance which can be given effect without such invalid part or parts.
- <u>Section 6</u>. This Ordinance shall be in full force and effect from and after its passage, approval, recording, and publication as may be required by law.
