Town of Eaton June 13, 2023 Regular Meeting

The Eaton Town Council met in a regular meeting. In attendance are Roger Wells, Dustin Reese, Meghan Deckman and Teresa Welsh. Daniel Blankenship was absent.

Vice-President Roger Wells called the meeting to order.

Clerk DeWees asked the Council if they want to pay it from the remaining loan funds. There is enough to cover it. Division C:

Discussion followed. Dustin Reese made a motion to approve closing Harris Street from Center Street to alley every third Friday from 7pm to 10pm. Meghan Deckman seconded the motion. Vote was 4/0. Motion carried.
