ORDINANCE NO: 2003- 6-1

OPERATION OF GOLF CART ORDINANCE

WHEREAS, the Town Council, of Eaton , Indiana hereby determines the need to pass an ordinance on 'Operation of Golf Carts'.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF EATON, INDIANA:


- (A) a "golf cart" is a gas or electric motorized four wheeled cart designed to carry people and / or materials
- (B) The operation of golf carts are permitted within the boundaries of the Town of Eaton ,Indiana, only upon Compliance with the requirements set forth in this Ordinance.
- (C) No person shall operate a golf cart within the boundaries of the Town of Eaton , Indiana without frist Completing each of the following provisions:
 - (1) The operator must be ^{sixteen (16)} ~~eighteen (18)~~ years of age or older;
 - (2) The operator must have a valid identification card, operator's license, chauffer's license or public passenger chauffeur's license issued by the Indiana Bureau of Motor Vehicles;
 - (3) The owner / and or operator shall allow the Town Marshal or representative of the office of the Town Marshal to inspect the golf cart;
 - (4) The owner / and or operator shall provide the Town Marshal or a representative of the office of the Town Marshal with proof of financial responsibility.
- (D) The Town Marshal or a representative of the office of the Town Marshal shall issue a three (3) digit Identification number to the operator of the golf cart after all of the requirements of section (B) have Been met. The identification number shall be placed on the backside of the golf cart on the lower right Side using three (3) inch numbers.
- (E) The operator of the golf cart shall place a slow moving vehicle sign on the rear of the golf cart.
- (F) Golf carts shall be equipped with two (2) headlights and two (2) taillights. These head and taillights Shall be operated at all times during operation of the golf care.
- (G) Golf carts must also be equipped with a rear view mirror.




- (H) Golf carts shall only be operated on the streets and roadways of the Town of Eaton, No golf cart may travel on State Road 3 North.
- (I) No golf carts shall be operated on any sidewalk located within the boundaries of the Town of Eaton, Indiana.
- (J) The operator of the golf cart shall abide by and follow all Indiana motor vehicle and Traffic laws and yield the right away to all motor vehicle traffic.
- (K) A violation of this Ordinance may result in the following penalties:
 - (1) A fine in the sum of Fifty Dollars (\$50.00) for the frist offense;
 - (2) A fine in the sum of Seventy-five Dollars (\$75.00) for the second offense;
 - (3) A fine in the sum of One Hundred Dollars (\$100.00) for the third or subacquent Offenses;

This ordinance shall be effective ten (10) days after publication. Passed and adopted by the Town Council on the 26 day of June, 2003


