Council President Blankenship called the meeting to order.

Hicks made a motion to approve the minutes of the April 2, 2019 and April 16, 2019 meetings. Welsh seconded the motion. Motion carried.

Matt Cull stated that the red dump truck we have been using for patching isn't rated to haul the total patcher. The white dump is having light problems. Discussion followed. IMEL in Bluffton has a truck with a plow package. Discussion followed. Hicks made a motion to spend up to \$60,000.00 from EDIT Funds. Welsh seconded the motion. Motion carried. Cull is to get a quote and see about trade in value for the red and white dump trucks.

Hunt presented the Council with a quote from BBC Pump and Equipment Co. for a pump for the sewage plant for \$23,217.00. Hicks made a motion to purchase the pump for \$23,217.00 from BBC Pump and Equipment Co. Welsh seconded the motion. Motion carried.

Hunt said due to counter space he would like to get a cheaper fridge. The current one in the plans is too big. It would be cheaper for him to go get one and not the contractor. Discussion followed. Hunt to get quotes for the next meeting. He would also like to get a new office phone and a printer with scanning ability. Hicks made a motion to purchase office phone for under \$50. Welsh seconded the motion. Motion carried. Welsh made a motion to purchase a printer/scanner for under \$100.00. Hicks seconded the motion. Motion carried.

B. Wright and T. Little John brought up Harris Street needing fixed. Discussion followed. It will be fixed after the road is torn out and repaved.

Snodgrass would like to pay the Vet bill the Town received from EDIT Funds. Welsh made a motion to pay \$2,601.60 from EDIT Funds. Hicks seconded the motion. Motion carried.

Phil Greene Ast. Fire Chief presented the council with a quote from T.C. Enterprises for \$8,695.00. Discussion followed. Hicks made a motion to purchase the trailer for \$8,695.00 to be split between Fire, Water and Sewage departments. Welsh seconded the motion. Motion carried.

Rachel from Commonwealth updated the Council on the Wastewater Project. Homes are currently not connected to the new lines. It will be done later in the project. Division B- Atlas Excavating, Inc is asking for a 30 day extension for lost time due to weather. There is no cost effect if granted. Project will move out to 12/16/19.

Building plaque is ready what does the Council want on it. Discussion followed. Welsh made a motion to sign project claims. Hicks seconded the motion. Motion carried.

R. Spitler, First Church of God- would like to have a 5k walk/run in town. He presented the Council with two possible paths. Discussion followed. Hicks made a motion to ok option b for the route. They will need to get permission from the county also. Welsh seconded the motion. Motion carried.

C. Nesbit presented the Council with a medical note for his grandson. Neighbor is burning trash. Discussion followed. Ast. Chief Greene will try to make the next call when there is one. Discussion followed.

Welsh made a motion to sign the claim docket. Hicks seconded the motion. Motion carried.

Waylon Wormer 314 N Long St, would like an extension until the 17th of May to pay his past due. Welsh made a motion to allow Wormer to pay on 5/17/19 his past due. Hicks seconded the motion. Motion carried.
