Chief Turner presented the Council with two applications for the Reserve Police Officers Carver and Burris. D. Reese made a motion to approve the applications of Carver and Burris for Police Reserve. T. Welsh seconded the motion. Motion carried.

Chief Turner presented the council with a quote from Belle Tire for \$1,198.58 for some work to be done on the 2013 Dodge Charger. T. Welsh made a motion to do repairs to the 2013 Dodge Charger for \$1,198.58 at Belle Tire. McDaniel seconded the motion. Motion carried.

J. Ratliff said the seal on the garage door at the Water Plant isn't working. It's \$15 to fix. Alarm system is a work in progress.

Travis Hunt stated that the pump is at the plant. Peerless will be in to start cleaning the wells.

Hunt stated that IDEM wants a letter stating what has been done and what is left to do.

Bridgett DeWees said the Utility Clerks printer stopped working and Parts can't be order for it any more. She wants permission to purchase a new printer. D. Reese made a motion to purchase a printer up to \$400.00. R. Wells seconded the motion. Motion carried.

Al Stong with Commonwealth presented the pay applications for Sewage Project. C. McDaniel made a motion to approve the pay applications. Wells seconded the motion. Motion carried.

Al Stong presented Change Order #B-7 from Atlas for a 30 day extension. D. Reese made a motion to approve change order #B-7. C. McDaniel seconded the motion. Motion carried.

Al Stong stated that the Sewage Project is coming to a close. Discussion followed.

Al Stong presented pay applications for Urgent Need Project. D. Reese made a motion to approve pay applications for Urgent Need Project. R. Wells seconded the motion. Motion carried.

Al Stong said OCRA 2020 Water Infrastructure bid should go out end of March beginning of April.

Al Strong presented the Council with an application for Operation Assistance for Water Department. Discussion followed.

Council was presented with an interlocal agreement with Delaware County to fix the bridge on Indiana Avenue that runs over Holdren Ditch. Welsh made a motion to sign the interlocal agreement with Delaware County. R. wells seconded the motion. Motion carried.

Council was presented a letter from Sites on North Street. She is asking for an adjustment on their sewage since they had hookup issues at their residence. Discussion followed. T. Welsh made a motion to adjust two weeks off of bill for sewage only. D. Reese seconded the motion. Motion carried.

- T. Welsh made a motion to approve building permits for Dan Nixon at 1000 S Romy Street. D. Reese seconded the motion. Motion carried.
- D. Reese made a motion to approve Brenda Brumley zoning variance pending she gets the remaining paperwork in and gets fee for publishing add paid. R. Wells seconded the motion. Blankenship abstained. Motion carried.
- D. Blankenship was speed limit signs ordered for 1000 N.

A.Blair asked if the rezoning would affect her property. No. Discussion followed. She also asked if Brumley knows about the flooding. Council told her yes she owns the property next door as well.

D.Reese presented the Council with a quote from Sweetwater for \$1,664.99 for a PA system. Discussion followed.

Police Chief Turner stated they will be doing a walk through at all three schools.

D. Reese made a motion to sign claim docket. R. welsh second the motion. Motion carried.
