Year End Meeting

The Eaton Town Council held the 2021 Year End Meeting. Present are Roger Wells, Teresa Welsh, and Dustin Reese. Daniel Blankenship and Clay McDaniel was absent.

Vice-President Roger Wells called the meeting to order.

Teresa Welsh made a motion to approve the minutes for December 14, 2021 Regular Meeting. Dustin Reese seconded the motion. Vote was 3/0. Motion carried.

Travis Hunt Water and Wastewater Operator. Stated that wastewater Apprentice Bruce DeWees III is doing good.

Roger Wells read Ordinance 2021-12-16 by title for the second time. Dustin Reese made a motion to pass Ordinance 2021-12-16. Teresa Welsh seconded the motion. Vote was 3/0. Motion carried.

Teresa Welsh made a motion to have Roger Wells represent the Town of Eaton on the ECI Regional Planning District, Inc.. Dustin Reese seconded the motion. Vote was 3/0. Motion carried.

Council was presented with the 2022 State and Local Fiscal Recovery Funds Plan. Discussion followed. Teresa Welsh made a motion to approve the 2022 State and Local Fiscal Recovery Funds Plan. Dustin Reese seconded the motion. Vote was 3/0. Motion carried.

Roger Wells made a motion to transfer \$15,000.00 from Fire Department Fund to Fire Equipment Fund. This is \$5,000.00 for the last three years it was not done. Teresa Welsh seconded the motion. Vote was 3/0. Motion carried.

Roger Wells made a motion to sign the claim docket. Teresa Welsh seconded the motion. Vote was 3/0. Motion carried.

Dustin Reese asked if the Town has donated to the Eaton Community Food Pantry this year. Clerk thinks we have. Discussion followed.

Council asked Clerk about 104 E Harris Street eviction, where are we on the animal ordinance, and about the easements. Clerk stated she has talked with John Brookes and is waiting on him to get back with her. Roger Wells is going to get with Mr. Brooke's to see where we are at.

Travis Hunt stated that Westrock has started discharging into our system. Discussion followed.

Travis Hunt stated that the leak at 305 N. Meridian is fixed. He went over how it was found and fixed.

There being no further business to be brought before the Council at this time Teresa Welsh made a motion to adjourn the meeting. Dustin Reese seconded the motion. Vote was 3/0. Motion carried.
